### **TRY ON**

All dresses require a \$50.00 deposit prior to shipping. Deposit includes the following:

\$15.00 shipping and insurance plus \$20.00 try-on fee (only one try-on fee will be waived if a dress is rented. Should the dress not be rented, the remaining \$15.00 will be refunded to the customer or credited toward the rental fee.

Unrented dresses must be returned within 2 days of receipt in a clean, unused and in undamaged condition or the status will be considered a rental and all applicable charges will apply.

## Try-on and Rental Agreement

### Additional Terms and Conditions:

1. Dresses must be returned no later than 3 days after event date.
2. Customer is responsible for late charges at \$10.00 per day, up to full value of the dress, if the item is not postmarked by the 3<sup>rd</sup> date following the event.
3. Customer agrees to purchase insurance for the value of the dress and provide a tracking number.
4. If insurance is not purchased and dress is lost, customer agrees to pay full value of the dress minus deposit (s).
5. Rental prices do not include \$15.00 shipping and insurance or a \$20.00 cleaning fee (these fees are added to the rental price).
6. Refund of deposit is contingent on late charges and damages resulting from unauthorized alterations.
7. Minor repairs will impose additional deductions from the deposit and customer may be required to pay additional charges if the damage exceeds the deposit, but will not exceed the full value of the dress.
8. Repairs will be charged to customer if dress is returned damaged; not to exceed full value of the dress.
9. Customer agrees not to alter dresses without the express written consent of a By Dancers, Inc. Officer or customer will be financially responsible for the full value of the dress.
10. By Dancers Inc. is not responsible for any wardrobe malfunctions, ballroom scores, or injuries that may occur due to wardrobe malfunctions.
11. Rental fees may be applied toward the purchase of a dress specific to the dress rented.
12. The use of any tanning products that stain the dress (es) are prohibited. If the dress is returned stained, charges will be assessed up to the full value of the dress, if the dress does not come clean.
13. All dresses are rented in "AS IS" condition.
14. Customer agrees to pay all applicable fees associated with the rental or try-on of the dress (es).
15. A 7 day cancellation is required on all dress placed on hold for an event. If 7 day cancellation is not met, the deposit is considered forfeited and non-refundable.
